Minutes of the Annual Meeting of the Pontyclun Community Council held in the Pontyclun Community Centre, Pontyclun, at 7.30p.m. on Wednesday, 8 May, 1991.

#### 1. Apology for absence

An apology for absence was received on behalf of Community Policeman Steve Keddle.

#### 2. Retiring Chairlady's Report

The retiring Chairlady, Councillor Mrs Anita Burton, outlined the achievements of the Community Council during her year as Chairlady. She paid tribute to the support she had received from her colleague Members and, in particular, the help which had been readily given from members of the public in organising the sponsored walk in aid of kidney research.

The report was noted.

#### 3. Election of Chairman

RESOLVED: That Councillor Professor Bowen be the Community Council's Chairman for the 1991/92 municipal year.

#### 4. Election of Vice-Chairman

RESOLVED: That Councillor Mr T J Burton be appointed Vice-Chairman of the Community Council for the 1991/92 municipal year.

#### 9. Matters arising

## (a) Footway lighting. Windsor Field

The Clerk said that he was pleased to be able to report that at last the footway lighting across the Windsor Field was connected and working properly.

The report was noted.

#### (b) Former Goods Yard, Pontyclun

The Clerk reported that he had made exhaustive enquiries with the separate divisions of British Rail to establish whether there were any plans in existence, or proposed, for development on the site of the former Goods Yard in Pontyclun. It appeared that while there were outline plans in existence to build a station on the site of the former Llantrisant station, there were no proposals to build on the site of the former Goods Yard.

The report was noted.

## (c) <u>Ivor Woods</u>, <u>Brynsadler</u>

#### (i) Grant of Wayleave

The Council discussed Appendices 3,4 and 5 to the Agenda. The Clerk also advised the Council that he had been informed by the District Auditor that an allegation that the Council had acted improperly in the matter had been made by Mr Evan G Jones, a director of J&G Developments (South Wales) Ltd.

- RESOLVED: (i) That the Council re-affirm its view that it had, at all times, dealt with the matter of the wayleave in a proper manner.
  - (ii) That the Council obtain advice from its legal advisers on the courses of action open to the Community Council in dealing with the belated application for wayleaves to lay additional services through the Woods.

## (ii) Tree planting

The Clerk reported that the Community Council had fulfilled its obligations to replant trees in the Woods under the Consent to Fell which had been granted to the Community Council's predecessor authority, the former Llantrisant Community Council. The replanting had been carried out by 31 March. 1991. and had been completed to the satisfaction of the County Council's Planning Officer.

#### (iii) Land slippage

The Clerk informed the Council that the civil engineering works designed to stabilise the land between The Hollies and the river Ely would commence shortly. Access to the site would be gained between the entrance to the estate and the first house.

It had been hoped to enter a winning team from the competition in the HTV series " Jeux Sans Frontieres" 1991.

## 11. <u>Matters arising</u>

#### (a) Planning applications No.s 56/0185/91 and 56/0186/91

#### 13. Offer to lease land in Miskin

The Clerk informed the Council that he had received a telephone call from Lady Caroline Rhys-Williams offering the Council the opportunity to lease the land around St David's Church in Miskin. It was proposed that the land would be leased for a period of 99 years. A similar offer had been made to the Church in Wales but the offer had been declined.

RESOLVED: That the Clerk write to Lady Caroline requesting full details of the terms of the proposed lease and that the Council discuss the matter fully at a later meeting.

## 14. <u>Mineral Local Plan for Limestone</u> in Mid Glamorgan Part 4 - Hendy Quarry

#### 18. Reports from Members

#### (a) Fly nuisance

Councillor Moir reported that residents in Miskin had suffered a nuisance caused by swarms of flies. It was unclear whether the source of the problem was the former sewerage works or whether it was the landfill tip operated by the Borough Council.

RESOLVED: That the matter be referred to the Chief Environmental Health Officer.

#### (b) Dust nuisance

Councillor Moir stated that it was his intention to raise the matter of dust nuisance to Miskin residents at the next meeting of the Hendy Quarry Liaison Committee. The problem was particularly noticeable where residents had installed uPVC windows.

The report was <u>noted</u>.

## (c) Renewal of fence - Fire Station

Councillor Norman said that he was pleased to be able to report that after many months of pressure the fence at the boundary of the Pontyclun Fire Station had been repaired.

The report was noted.

#### (d) Renewal of fence - Playing Fields

Councillor Norman said that he was pleased to be able to report that the dilapidated fence separating the children's playground from the schools' playing fields off Cowbridge Road, Pontyclun, had been renewed by the County Council.

The report was noted.

# (e) <u>Proposal to amalgamate Maesyfelin Infants'</u> and <u>Pontyclun Junior Schools</u>, <u>Pontyclun</u>.

Councillor Norman reported that the Education Authority had recently proposed that the Maesyfelin Infants' School and the Pontyclun Junior School be amalgamated. The proposal had met with very little support at School Governors' level and no support at parent level when a special meeting to discuss the proposal had been held. It was understood the proposal had now been abandoned.

The report was noted.

## (f) <u>District Council Elections</u>, 1991

Councillor James reported that following the recent District Council elections, the Taff Ely Borough Council was now a "hung" Council where no one political party had overall control of the Borough Council. He foresaw a situation where parties who were previously in a minority situation having greater say in the new administration.

The report was noted.

#### (g) "Chairman's business"

The Chairman, Councillor Bowen, raised the possibility of including, on each Council Agenda, an provision for "Chairman's business". He proposed that the facility would provide a means for making important announcements in addition to items of courtesy.

RESOLVED: That provision be made on all future Council Agendas for "Chairman's Business"

## 19. Any other business of an urgent nature

## (a) Government White Paper on medical care

Councillor Norman referred to the recent publication by the government of a White Paper dealing with medical care, and in particular the facility for "opting out".

Councillor Norman believed that there was widespread confusion about the proposals and was aware that members of the doctors' surgery in Pontyclun had given talks to various groups to clarify the proposals.

<u>RESOLVED:</u> That an invitation be extended to a member of the doctors' surgery to address a future meeting of the Community Council on the White Paper.

#### (b) Route of the proposed Pontyclum Bypass

Councillor Dilworth reported the concern of residents in Danybryn, Brynsadler, about the uncertainties surrounding the route of the proposed Pontyclun Bypass. Councillor Dilworth asked if there was any definitive information on the route of the proposed Bypass.

The Chairman responded that the information which he had received concerned the A4119 Corridor Study. The proposed Pontyclun Bypass in the Study was represented only by a pencil line on a map and could not be regarded as being definitive. The Chairman promised to provide a copy of the A4119 Corridor Study for the information of the Community Council.

The matter was noted.

## (c) River Ely clean up

Councillor James reported that his plans for organising a clean up of the river Ely in the Community were proceeding satisfactorily. He was hopeful that his plans would be finalised by the end of June. In the meantime, he was pleased to be able to let the Council know that he had secured a grant of £50.00 towards the work from the Prince of Wales Committee and had obtained a commitment from the Borough Council that it would provide skips for the disposal of the rubbish which was collected.

The matter was noted.

## (d) Land adjacent to The Paddocks, Brynsadler

Councillor Mrs Burton spoke of the deep concern of residents at The Paddocks. Brynsadler, over the recent erection of a sign on land immediately to the south of The Paddocks, indicating that the land was to be sold at auction as building land.

Councillor T J Burton gave notice that he wished to discuss the erection of a bus shelter in Miskin at the next Community Council meeting. He asked Members to give some thought to possible sites by the next meeting.

## (g) Notice of Motion

Councillor Phillips gave notice that she wished to discuss the possibility of providing a wheelchair access facility for the disabled wanting to access the Ivor Woods.

#### (h) Children's Playground, Pontyclun

Councillor Bendle drew the Council's attention to the practice of some dog owners in allowing their pets to foul the grassed area in the children's playground in Pontyclun. He asked whether it would be possible to to erect signs in the playground to discourage dog owners from allowing their dogs to foul the area.

RESOLVED: That the Clerk pursue the matter with the Borough Council.

#### (i) War Memorial, Miskin

The Clerk reported that the Parochial Church Council of St David's Church, Miskin, had made a donation of £100.00 to the costs of the Community Council in renovating the War Memorial in Miskin.

RESOLVED: That the Glerk thank the the Parochial Church Council for their kind donation.
