

- 3. <u>National Forum of the Wales Association of Community and Town Councils, Aberystwyth 13 July, 1991</u>

The Council discussed the nomination of a representative to attend the National Forum of the Wales Association of Community and Town Councils on 13 July, 1991, in Aberystwyth, called to formulate the Association's views on the future structure of local government in Wales.

### 5. Miskin Churchyard

## 6. Reports from Members

## (a) Planning Application No.56/0302/91

Councillor James reported that the Borough Council's Planning Committee had refused the planning application for residential development at the site of Mineral Supplies in Mwyndy.

The report was noted.

## (b) Dipali restaurant. Llantrisant Road. Pontvolun

Councillor Mrs Burton reported that there had been a number of complaints from residents living in the vicinity of the Dipali restaurant about the disposal of waste food. Councillor Burton had personally sought the assistance of the Chief Environmental Health Officer and had requested the Clerk to convey residents' concern to the Borough Council.

#### 7. Any other business

## (a) Planning Notification for Week No. 26

The Clerk distributed copies of Weekly Notification No. 26 which had been received too late for inclusion with the Agenda.

RESOLVED: That the Clerk write to the Borough Council to convey the Council's opposition to the application to develop land at the site of the former Bethel Church, Pontyclun, on the grounds that:-

(a) The site is unsuitable for the proposed development.

(b) There is inadequate provision for parking facilities and existing congestion in Lewis Street will intensify.

(c) The proposals show a poor mix of dwellings.

(d) No effort was made to consult existing residents of Lewis Street for their views on the unusual development proposed for the site.

(e) Residents of the proposed development would be subject to nuisance due to the presence of an adjacent bus stop in Llantrisant Road.

# (b) <u>Annual Conference of the Wales</u> Association of Community and Town Councils

The Clerk distributed copies of the notification he had received about the Annual Conference of the Wales Association of Community and Town Councils to be held on 12 October, 1991. The notification had been received too late for inclusion on the Agenda.

- RESOLVED: (i) That the Council be represented at the Conference by the Chairperson, Vice-Chairperson and Councillor Dilworth.
  - (ii) That the previously approved motion calling for an increase in County Councils' legal resources to resolve cases of denial of access to public rights of way be submitted for debate.

#### (c) Speeding vehicles - A4222

Councillor Dilworth referred to the complaint he had made to the police about speeding vehicles on the A4222 between Talbot Green and Pontyclun. Councillor Dilworth reported that he had received a reply from the Chief Constable stating that officers from the Traffic Management Department had paid special attention to the area, recently, and a number of persons had been reported. The area would continue to receive police attention.
