#### 1. Apologies for absence

There were no apologies for absence.

## 2. <u>Declarations of interest</u>

Declarations of interests were sought from Members.

Councillors Dilworth, Norman and Rea indicated that they would be declaring an interest in the following matters and for the reasons indicated:

### 3. Chairperson's/Leader's business

The Chairperson, Councillor Rea, reported on his attendance at a seminar organised by the Borough Council on regeneration. The seminar was well attended by a good cross section of the community and was facilitated by chief officers of the Borough Council.

The Leader, Councillor Huish, added that the Borough Council had created twelve Area Regeneration Committees with the aim of guiding the Cabinet towards making public decisions. The creation of Area Regeneration Committees was an important step forward.

The seminar had been addressed by Professor Kevin Morgan and it was pleasing to see a large number of people in attendance. A significant number of ideas were forthcoming from the seminar and would considerably assist the Council in its decision processes.

Councillor Huish also reported that a bid for capital money had been submitted to the National Assembly to enable the provision of an astro turf pitch and changing rooms at Y Pant Comprehensive School.

The reports were noted.

#### 4. Police matters

#### (i) Police report

In the absence of P C Keddle there was no police report.

## (ii) Possibility of the contraction of disease

Councillor Dilworth reported an incident where a racing pigeon, which had alighted in School Street, Pontyclun, had been killed and the carcass thrown against a wall. The incident was unpleasant and had caused distress to residents in the Street.

It was believed that children were responsible for the incident and the police had been informed. The Pigeon Racing Society had also been informed of the event..

Councillor Dilworth advised Members that, apart from the distasteful event, some pigeons were known to carry disease which could be passed on to human beings. Councillor Dilworth believed that the dangers should be brought to the attention of children in local schools.

**RESOLVED:** That the Clerk contact local schools to advise of the possible dangers in handling pigeons.

#### 6. Matters arising

#### Members' Code of Conduct

The Council considered the letter of 19 April from the County Borough Legal and Democratic Services Officer and a copy of a report to the Borough Council's Standards Committee on 1 March, 2002 with respect to Dispensations. The Appendix to the report set out the circumstances when dispensations may be granted and paragraph (a) appeared to cover the circumstances raised in a query by a neighbouring community council.

The Community Council was reminded that if any of its members wished to apply for dispensations they should comply with the requests of paragraph 3.6 of the Report. The Community Council Sub Committee of the Standards Committee would consider any applications for dispensations.

### 7. Matters reported for decision

## (a) Work undertaken by Groundwork at the Ivor Woods

The Council received the letter of 2 April, 2002, from Groundwork Merthyr & Rhondda Cynon Taff in which the Council was asked to arrange for the signature of the project brief and whether it wished to explore the possibility of engaging Groundwork on future projects.

Councillor Huish drew the Council's attention to the recent unexpected death of Mr Terry Dunn, the senior planning officer of the Borough Council. His untimely death would be deeply felt by his family and have a significant effect on the work of the former planning department in the short term.
