# Planning application No. 04/0719/10

The Clerk reported that he had had obtained further details of this application from the Planning Authority. The details were examined by Members.

The Clerk advised that while the plans accompanying the application were not conclusive, it seemed likely that the applicant for consent had re-submitted an application which was understood to have been first approved in 1981. The development necessitated the construction of a crossover from the public highway over land in the ownership of the Community Council where the applicant held a long term lease. Earlier correspondence from the applicant's had indicated that the applicant was fully aware of that the land was in the ownership of the Community Council.

#### **RESOLVED:**

While the Council wished to be as helpful as possible it expressed reservations about insurance implications and the likelihood of creating a precedent for other voluntary groups in the Community. There was unanimous support from the Council for the principle of assisting the Management Committee in providing facilities for the public.

RESOLVED:

A formal response on the request had now been received from the Borough Council to the effect that Palalwyf Avenue was not on the current list of street in the Borough where traffic calming measures were due for implementation. It was

suggested that breaches of existing speed limits should be brought to the attention of the police.

#### (b) Hendy Quarry, Miskin
