Minutes of the meeting of the Pontyclun Community Council held at the Pontyclun Community Centre, Pontyclun, at 7.00 pm on Wednesday, 7 November, 2001.

## ALSO IN ATTENDANCE: Two members of the public

#### Apologies for absence 1.

Apologies for absence were received on behalf of Community Councillors J R Dilworth and Mrs P Thomas. The Clerk reported that P C Keddle had offered his apologies for absence since he had been required to attend Ton Pentre Police Station on urgent police business.

#### Councillor J R Dilworth 2.

The Clerk reported that Councillor Dilworth's mother had recently passed away. On behalf of the Council the Clerk had sent a letter of condolences to Councillor Dilworth.

#### Chairperson's/Leader's Business 3.

#### **Speed Cameras**

The Chairman, Councillor Rea, wished to place on record his thanks to Councillor Huish for his invaluable assistance in obtaining two speed cameras located in the Community. One camera had been erected near Y Pant Comprehensive School and the other in Groesfaen. The Chairman was convinced that the cameras would make a major contribution towards improving road safety at both locations.

## (i) Rhondda Cynon Taff County Borough Council - Reserves

The Leader of the Council, Councillor Huish, was pleased to be able to report a major improvement in the finances of the Rhondda Cynon Taff County Borough Council. He reported that reserves had increased to £8.2m and the Authority had been taken off the list of local authorities "at risk".

The report was noted.

## (ii) Rhondda Cynon Taff County Borough Council - DSOs

Councillor Huish stated that he was also pleased to report a significant improvement in the financial position of the Borough Council's Direct Service Organisations. The improvements would help to protect local jobs in the Borough.

The report was noted.

## (iii) Y Pant Comprehensive School - Capital investment

Councillor Huish was pleased to be able to report that in addition to the major capital programme planned for Y Pant Comprehensive School, work would shortly begin on access improvements.

The report was noted.

### (iv) Future of community councils

Councillor Huish advised that the future of community councils was under review and that the National Assembly would shortly be calling for evidence. An opportunity for the Pontyclun Community Council to state its views would be given in due course.

The report was noted.

#### (a) Installation of CCTV in Pontyclun

The Clerk reported that he had been advised by Rhondda Cynon Taff County Borough Council officers handling the installation of CCTV in Pontyclun that it was likely that there would be sufficient funding available for the erection of four CCTV cameras in Pontyclun. The siting of the cameras would accord with the plans previously placed before the Council.

Officers of the Borough Council had provisionally agreed to attend a meeting of the Community Council in January to give a presentation on CCTV.

It was anticipated that the full CCTV system would be in operation in early summer, 2002.

## (b) Nomination to Governing Bodies

#### RESOLVED:

- (i) That Councillor C Davies be nominated to the vacancy on the Governing Body of Pontyclun Primary School.
- (ii) That Councillor M Rea be nominated to the vacancy on the Governing Body of Y Pant Comprehensive School.

#### (c) Proposed parking restrictions

The Council received the response of the Borough Council to the Community Council's earlier enquiry about when the proposed parking restrictions for Heol yr Orsaf, Pontyclun, were likely to come in to effect.

The reply stated that responses to the consultation exercise were being considered and, if it was decided to go ahead with the proposed restrictions, the next stage would be the publication of the proposals. Further progress would depend on representations received.

That the position be noted and that the Borough Council be asked to proceed as a matter of urgency given the regular congestion in Heol yr Orsaf

#### (d) Grant application - Pontyclun Juniors AFC

### 7. Matters reported for decision

# (a) <u>Disabled persons' access to the Ivor Woods – options for completion</u>

The Community Council discussed the three options submitted by Groundwork for completion of the disabled persons' access to the Ivor Woods.

Councillor Huish reported that he had contacted the Property Services Department of the Rhondda Cynon Taff County Borough Council and established that a new lease had been negotiated with the Pontyclun Football Club. If required, it would be possible to renegotiate the lease.

#### **RESOLVED:**

That the Clerk contact the Pontyclun Football Club with the proposals put forward by Groundwork, indicating that the Community Council's preference was for Option 1, and inviting the Football Club's comments.

## (b) New Ethical Framework - Standards Committees

The Council discussed the letter from the County Borough Legal and Democratic Services Officer, dated 22 October, 2001, about the formation of a Standards Committee and the need to nominate a Community Council Panel member and members to the Standards Committee.

#### RESOLVED:

- (ii) That Councillors C Davies, J G Davies and M Rea be nominated as the Community Council's members to the Standards Committee
- (iii) That the Borough Council be advised that a separate sub committee of the Standards Committee be established to deal exclusively with community council matters.

#### (c) Christmas celebrations in the Community

- (v) That a feasibility exercise be carried out into the possibility of erecting Christmas tree lights in Miskin and Groesfaen.

## (a) <u>Proposals for development at the former Talygarn</u> <u>Rehabilitation Centre</u>

The Clerk advised that Mr Chris Nicholson of Cowbridge Developments had agreed to attend the December monthly meeting of the Community Council to update the Council on the latest position with the proposals for development at the former Talygarn Rehabilitation Centre.

The report was noted.

## (b) Traffic management, Cowbridge Road area, Pontyclun

The Council received the reply of the Borough Council over earlier Community Council concerns about the practice of certain motorists in taking shortcuts through the lanes running parallel with Cowbridge Road, Pontyclun.

The reply stated that as the lanes in question allow servicing and access to off street parking for adjoining properties, any effective measures to limit shortcuts would interfere with legitimate local activities.

**RESOLVED**: That while the Council would not want to interfere with the legitimate rights of access from the lanes, the Borough Council be asked if some a simple method of controlling the activities of drivers taking shortcuts could be introduced.

#### (c) Grassed area off Maelog Close, Pontyclun

The Council noted that the Clerk had written to the Borough Council in an attempt to discover the ownership of the grassed area off Maelog Close, Pontyclun.

#### (d) Refurbishment of footway, Cowbridge Road, Brynsadler

The Council noted that the Clerk, following local concerns, had written to the Borough Council about the narrowing of the footway in Cowbridge Road, Brynsadler.

#### (e) Tree nuisance, Rhyd y Nant, Pontyclun

The Council noted that the Clerk, following a complaint from a resident of Rhyd y Nant, Pontyclun, had written to the Borough Council to establish whether that Council could offer any assistance over the issue of a tree nuisance in Rhyd y Nant.
