I. Minutes of the meeting of 2 December, 1985

RESOLVED: That the minutes of the Council's meeting of 2 December, I985 be approved as an accurate record.

Matters arising

(a) Refurbishment of the public toilets

Members noted with concern that the exterior walls of the toilets had already been defaced by vandals.

- RESOLVED: (i) That the exterior walls of the toilets be repainted dark brown.
 - (ii) That a light fitting be erected at the rear of the toilets to provide illumination during the hours of darkness to deter vandals.
 - (iii) That the "car park" sign on the exterior wall of the toilet be reinstated.
 - (iv) That the Clerk make the necessary arrangements.
- (b) Community Programme- Report of the Working Group's meeting with representatives of NACRO

The Clerk reported on the discussions which had taken place with representatives of NACRO.

An outline of work in the Community had been provided to NACRO who, following their site visit on I8 December, I985, had agreed to submit a draft scheme for approval to the Community Council prior to submission to the Manpower Services Commission. The matter was noted and members expressed their appreciation of the considerable contribution made by Councillor James in the matter.

Community Council Precept for I986/87

The Clerk reported on the enquires he had made about the arrangements for notifying the Borough Council of the Council's precept requirement for I986/87.

Footbridge at Ivor Park

Councillor James reported that he had arranged for a work specification to be drawn up on the work required at the Ivor Bridge.

RESOLVED: That no action be taken to seek tenders for the reinforcement work needed to the foundations of the bridge until the specification arranged by Councillor James had been received.

5. Post of Handyman

Members discussed the resignation of the Council's handyman.

6. Congestion in Clun Avenue, Pontyclun

Members discussed the minute of the meeting of the Borough Council's Special Sub Committee of I3 November, I985 on congestion in Clun Avenue, Pontyclun. Members expressed their approval that the traffic problems in Clun Avenue were being recognised. It was accepted by Members that it was unlikely that there would be an "ideal" solution to the problem and concern was expressed about possible safety hazzards arising out of a re-routing of traffic.

RESOLVED: That a request be made to the South Wales Constabulary for the observations of the local Traffic Inspector in the matter.

7. Society of Local Council Clerks- I985 Salary Agreement

The Clerk reported on the agreement between the National Association of Local Councils and the Society of Local Council Clerks on the revised salary scales operative from I July, 1985.

<u>RESOLVED</u>: That the provisions of the agreement be implemented by the Council.

8. Proposed Welsh Office in Brussels

Councillor James reported on his attendance as a delegate of the Council to the Conference in Swansea on the proposed establishment of a Welsh Office in Brussels.

The Clerk reported that following Members' concern about the possible severing of Footpath No 4 (Llanharan) as the result of the construction of the Talbot Green By-pass he had written to the Clerk of the Llanharan Community Council to establish whether that Council had made any formal representations to the County Council.

(iv) Proposed Closure of Pontypridd Cottage Hospital

The Clerk read out a letter which had been received from the Chief Executive and Clerk to the Taff Ely Borough Council in which the Community Council's support was sought in opposing the proposed closure of the Pontypridd Cottage Hospital.

RESOLVED: That the Clerk send an appropriate letter, opposing the closure of the Hospital, and among other things, emphasising the invaluable contribution made by the smaller hospitals in taking pressure off the larger hospitals.

(v) Poor road surface opposite St David's Court

Members were told of the poor condition of the road surface opposite St. David's Court in Pontyclun as the result of recent works by the public utilities.

RESOLVED: That the Clerk contact the Mid Glamorgan County Council in an effort to expedite reinstatement works.

(vi) Acknowledgement of Assistance

Members were informed of the assistance given by Mrs. Thomas of No 56 Heol Miskin, Pontyclun, in taking delivery, and in arranging storage facilities for the materials used in the repair of the bus shelter in Heol Miskin.
