1. Minutes of the meeting of 3 February, 1986

RESOLVED: That the minutes of the Council's meeting of 3 February, 1986, be approved as an accurate record.

2. Matters arising

(a) Boundary Commission Reports

RESOLVED: That in view of the Boundary Commission's recommendations for two members to represent the Community of Pontyclun on the Taff Ely Borough Council, the Clerk establish the content of the Orders approved.

(b) Ivor Bridge

RESOLVED: That the Council reaffirm its earlier decision to procede with the reinforcement works at the bridge as a matter of urgency.

(c) Concurrent Functions - Allotments

The Clerk reported that the Borough Council had agreed to the leasing of land in Clun Avenue, Pontyclun, to the Community Council for the purpose of providing allotments. The Borough Council's valuer would be writing to the Community Council with the terms of the proposed leasing arrangement.

The matter was noted.

(d) Children's Playground, Pontyclun.

The Clerk reported that the Borough Council had taken action to clear the playground of molehills.

(e) Community Programme - Premises

(f) Noticeboard - St Paul's Church

The Clerk reported the agreement of the Parochial Church Council to the erection of a Community Council Noticeboard outside St Paul's Church, Pontyclun, subject to no political notices being displayed and the maintenance of the noticeboard being the responsibility of the Community Council.

RESOLVED: (i) That the Clerk write to the Parochial Church Council thanking the Council for its cooperation.

(i) That the Clerk arrange for the Council's handyman to suitably adapt and erect a noticeboard in the Church grounds.

(g) Dog Control

The Council discussed the matter of dogs fouling footways in the Community and considered the advice offered by P C Guildford.

RESOLVED: That the Clerk make enquiries of the Borough Council to establish the existence of any bye laws dealing with the problem. If bye laws exist the Council would consider how best to bring them to the attention of Community residents.

(h) Community Wheels

The Clerk reported that the inaugural meeting of Community Wheels had been arranged for 7.30pm on Wednesday, 19 March, 1986, in the Pontyclun Community Centre.

(i) Refurbishment of Public Toilets, Pontyclun

In response to a question from the Council the Clerk confirmed that the contractor who was carrying out the refurbishment works at the toilets intended returning when weather conditions improved to repaint the exterior walls.

The Clerk reported that the matter had first been considered by the Council at its meeting of 2 December, 1985, Planning permission had subsequently been given by the Borough Council on 19 December, 1985.

10. Storage of Handyman's Tools

The Clerk reminded members that temporary storage facilities for the handyman's tools had been arranged at the premises of the School Playing Fields Unit at Miskin. It appeared from the enquiries made by the Clerk that there was a possibility of more suitable accommodation being available in the garage/workshop at the rear of the Post Office in Pontyclun.

RESOLVED:

That the Clerk make suitable arrangements for a valuer to assess a fair rent for the premises and to report back to the next meeting of the Council.

(a) Bollards on footpath at Heol Miskin

RESOLVED: That the Clerk again contact the County Engineer and Surveyor, conveying the anxiety of the Council over the matter and urging that a site meeting be held as soon as possible.

(b) Request for the removal of the bus shelter outside No 20 Llantrisant Road, Pontyclun.

The Clerk reported the verbal request by Mr G Clear of 20 Llantrisant Road, Pontyclun, for the removal of the bus shelter outside his home.

RESOLVED:

That the Clerk contact Mr Clear to inform him that while the Council had sympathy with his predicament they could not agree to the removal of the bus shelter. In addition that Mr Clear be requested to report any incidences of vandalism occurring at the bus shelter to the police.
