1. Election of Chairman

RESOLVED: That Councillor R G Norman be appointed Chairman of the Council for 1987/88.

2. Election of Vice-Chairman

3. Declarations of Acceptance of Office

Declarations of Acceptance of Office were completed by each member of the Council. The Declarations were witnessed by the Clerk as the Proper Officer of the Council.

RESOLVED: That the Chairman's Allowance for 1987/88 be fixed at £500.00.

(c) Upgrading of litter bins in the Community

RESOLVED: That the Council replace the existing oil drum type litter bins with the type of litter bins currently in use near the Llantrisant Leisure Centre. Additionally, that members report back to the next meeting of the Council with their respective ward's requirements.

(d) Fishponds at Talygarn - Obstructed footpath

The Clerk informed the Council that he had reported the obstruction of Footpath No 341, caused by the adjacent "fishponds" development to the Borough Council. The Borough Council had responded by acknowledging the problem and agreed that the matter would be taken up with the developer. However, it had been pointed out that a more pressing problem in the view of the Borough Council, connected with the development, was the construction of earth retaining walls in direct contravention of planning consent. The construction of the walls posed a threat of flooding to the Maesyfelin estate.

#### 8. Ivor Woods

(a) Report on the stability of trees within the landslip

The Clerk outlined the developments which had taken place since the first reports of land slippage had been received. The Clerk informed the Council that the landslip continued to be monitored and advised of the contents of the latest report.

# 9. Talygarn Tip

The Clerk referred to the decision of the Council on 1 December, 1986 to seek further information on Talygarn Tip. The reply of the Borough Council, dated 24 April, 1987, was discussed by the Council. Reference was made to the current application by the landowner for planning consent for the creation of a further tip on an adjacent site. The Council, at an earlier meeting, had unanimously opposed the further application and had conveyed its views to the Borough Council. Apublic meeting, called by the Pontyclum Environment Group had also strongly opposed the planning application and had also made representations to the Borough Council.

RESOLVED: That the matter be left in abeyance until the outcome of the planning application was known.

10. Adoption of sewers in Rhyd-y-Nant, Pontyclun

The Clerk referred to the decision of the Council on 2 March, 1987, to seek further details on the implications of getting the Welsh Water Authority to make a declaration to the effect that the sewers at Rhyd-y-Nant, Pontyclun, were vested in the W.W.A. The Borough Council, as agents for the W.W.A., were unable to provide details details of the implications.

RESOLVED: That the Clerk contact the W.W.A. direct to obtain their views on the making, and implications, of such a declaration.

11. Annual Conference of the Society of Local Council Clerks, 1987. - Report of the Clerk
