1. Apology for absence

2. Declarations of interest

Declarations of interest were invited from Members. There were no declarations.

3. Monitoring of Expenditure against budget for 2003/2004

The Committee reviewed its expenditure to 31 December, 2003, its projected expenditure to 31 March, 2004, and compared the information against its budget for 2003/04.
