(a) Planning application - Capel Llanillterne

The matter was brought before the Finance Committee as a matter of urgency since, if the Pontyclun Community Council was to lend support to the Pentyrch Community Council's opposition to the application, a letter opposing the application needed to be lodged with the Borough Council by 31 January, 1995.

RECOMMENDED: That the Community Council write to the Chief Planning Officer of the Borough Council opposing the application on the following grounds:

> that the proposal constitutes an (i) intrusion into open countryside.

- (ii) that there are other suitable sites within the area which have yet to be fully utilised.
- (iii)that the proposal conflicts with the Draft Borough Local Plan policies and objectives.
- (iv) that the proposal contravenes Department of the Environment recommendations against out of town developments particularly where there are no public transport facilities.
