The Council will consider new project together with the proposed revenue budget at its December 2016 meeting.

The Council carefully considered the request to increase the working hours of the Assistant Caretaker as outlined in the Clerks report and agreed to the contractual change.

# Councillor Brendan O'Reilly Car Park:

1 – 'I propose that the community council impose and enforce a two hour time limit on the car park as a matter of urgency. It appears that a lot of train users are parking there all day and while being sympathetic to those train users, it is an inappropriate use of the car park. It is interfering with people shopping and especially with users of the day centre. This is also having an adverse effect on business and is now urgent. I also propose that the day centre and the community centre through the community council could issue a card exempting certain individuals from this time limit: teachers / leaders who will be there for more than two hours; day centre and community council staff'.

Councillor O'Reilly's presented the above motion. The Council was unable to consider the proposed motion as the method of how to impose and enforce a two hour time limit in the car park and its resourcing had not been presented to enable the Council to make an informed decision.

Councillor Paul Griffiths reported to the Council of a recent Welsh Government budgetary provision made available to local councils to support car parking in town centres. Rhondda Cynon Taff County Borough Council currently has a standard charge in all of its car parks and is developing a proposal to introduce a two/three hour free parking in its car parks. Councillor Griffiths has requested that Pontyclun is included in its pilot.

Standing Orders suspended at 10 pm as business had not been completed.

#### Llantrisant Road:

2 – That the community council ask RCTCBC to lay the yellow line on Llantrisant Road as a matter of urgency and before any of the other proposed traffic works are carried out. There appears to me to be more people parking along here often spread out over a distance meaning that traffic has to weave. This is leading to traffic chaos at busy times and as the traffic has increased it is also affecting the traffic flow at non-busy times, in particular, trucks and buses are forced to wind around the parked traffic thereby blocking the road. The situation has deteriorated.

The Council was unable to consider Councillor O'Reilly's proposed motion as the statutory consultation by Rhondda Cynon Taff County Borough Council was still in progress.

"Why has the food hygiene rating of the Cafe 50 facility fallen from '5' under RCT to '3' currently? What is being done to rectify this?"
