i Councillor Paul Griffiths

1. Pontyclun Community Council supports the decision of RCT Council to include in its forward programme the conversion of the zebra crossing outside the Cooperative Store into a pelican crossing with lights, and, in addition, proposes a delivery bay to the south of the crossing.

It is willing to provide £10,000 financial support for the project from its reserve of £140,000 in order that this work can be undertaken early in 2016.

Members agreed that traffic congestion through the village continues to be problematic and agreed this proposal would help address the flow of traffic. Councillor Paul Griffiths also proposed this project is tied into designating a delivery bay for goods vehicles, with time restrictions, to the south of the crossing and incorporate the current disabled parking space.

Councillor Brendan O'Reilly

The Clerk reminded the Council following the Public Meeting in February, 2015, she had written to RCT CBC requesting yellow line to be placed at three other locations throughout the village.

[The Clerk has since checked back through records and for information the RCT CBC reply was tabled at the May 2015 meeting. RCT CBC replied by letter informing the Council its request had been listed and prioritised, but warned the time consuming and relatively lengthy process and its limited budget restricted the implementation of Traffic Regulations Orders to a few each year.

Members agreed to consult with residents on Llantrisant Road by letter to gain their views].

7 Matters arising from previous meetings – Action Table

Action 353 – Café 50

Councillor Paul Griffiths reported he had discussion the proprietors of both Porcellini's and the Deli.

Porcellini's proprietor was at ease with the traditional luncheon service provided by Café 50 but would have fears if the facility extended into non luncheon services. Councillor Griffiths confirmed that this was not the Council's intention but did inform the proprietor of the afternoon tea service, offered several times a year, at Café 50. These sessions offered service users a chance to further socialise and enjoy a light entertainment programme. Such events did not cause any concern to the proprietor.

The Deli's proprietor stated that she had no concerns with the service provided at Café 50.
