

The Clerk handed out the collated replies received to date and copies of the estimates attached. The Clerk was still waiting for several firms to forward an estimate.

Councillor Ken Forsdyke was asked to work with Clerk to produce a clear specification for the footbridge as the variation received by the Clerk were too wide to make effective comparisons. The Clerk handed out copies of the letters between Rhondda Cynon Taff County Borough Council and Youngs Solicitors representing one of the two landowners. In them progress to divert the footpath to date is detailed.
